

## e-IEP PRO 2021 Highlights / 2022 Forecast

We hope 2022 has started off well for you. As we begin the new year, we would like to reflect on some of the highlights from 2021 and share our forecast for the e-IEP PRO in 2022.

### \*\* HIGHLIGHTS FROM 2021 \*\*

**\*\* SUSTAINED STATE-WIDE ADOPTION** - In 2021, a significant number of Local Education Agencies (LEAs) in Arizona made the switch to the e-IEP PRO. Currently, over **519** Arizona LEAs are using the e-IEP PRO that are comprised as follows:

- 178 Arizona public school districts (~70% of Arizona public school districts)
- 332 Arizona charter and private schools (~60% of Arizona charter schools)
- 7 State and local agencies.

**\*\* 98% RETENTION** - In 2021, thanks to the loyalty and dedication of our customers, the e-IEP PRO maintained its *exceptional* retention rate. In the 21 years that the e-IEP PRO has been provided in Arizona, the e-IEP PRO has experienced a 98% retention rate of all LEAs sold. Arizona LEAs continue to experience that promises or claims of comparable special education management products and services do not match the strong and consistent services offered by the e-IEP PRO and its support team.

**\*\* CELEBRATED 24 YEARS OF SUCCESSFUL BUSINESS** – MediaNet Solutions, Inc. - Enhanced the Supporting Documentation module to allow updating/editing the file description, category and notes for current supporting document files;
- Updated the IEP Designer module to allow attaching Health Plan documents/forms to the IEP;
- Upgraded the Reporting Module to allow exporting most all reports to CSV, XLSX and other standard export formats.

**\*\* OVER 22,000 STUDENT RECORD TRANSFERS COMPLETED** - In the 2020-21 school year, over 22,000 electronic student record transfer requests were processed by the e-IEP PRO moving student data amongst districts, charter schools, and state agencies within Arizona. For the 2021-22 school year, e-IEP PRO is on pace to complete over 24,000 electronic student transfer requests.
